CURRICULUM UPDATES AND THEIR IMPACT ON SCHOOL MANAGEMENT PRACTICES

Abstract: Curriculum renewal influences not only educational content, but also overall school management practices. In this study, we investigate the impact of curriculum reform on school management practices with an interdisciplinary approach. Through a literature review, we identified various forms of impact, including changes in management paradigm, organizational structure, school culture, teacher skills, education quality, community involvement, management skills, resource quality, student involvement, and service quality. Our findings suggest that school management must adapt planning, training, resource provision, and community involvement to manage change.

regular evaluations are needed to develop more effective education policies and school management practices, with policy adjustments based on evaluation findings. Good communication and involvement of all stakeholders is the key to implementing significant changes in increasing educational effectiveness.

Introduction

In the era of globalization and rapidly developing technology, the educational curriculum must continue to be updated to suit the demands of the times and students' needs.¹ However, curriculum reform does not only involve changes in educational content, but also influences the way schools are managed and organized.² This phenomenon covers various aspects: (1) Increased acceleration of change, (2) Diversification of the curriculum, (3) Changes in the role of school principals and, (4) Increased Stakeholder Collaboration. This phenomenon shows that curriculum updates not only affect learning content, but also change the overall school management landscape³ Therefore, it is important for school management to understand the impact of curriculum reforms and develop appropriate strategies to manage changes effectively to improve the quality of education in their schools.

Curriculum renewal is an important effort to respond to the demands of current developments and prepare students to face future challenges.⁴ This can be seen in various countries, including Indonesia, curriculum renewal is often considered a crucial step in improving the quality of education.⁵ However, changes in the curriculum do not only cover aspects of subject matter, but also influence various aspects of

Furthermore, research from 15 entitled "Teacher Perceptions of Curriculum Renewal: Implications for School Management". Furthermore, research was conducted by 16 with the title "Strategies for Effective Implementation of Curriculum Renewal: Insights from School Leaders".

In this research, novelty lies in the interdisciplinary approach used to analyze the impact of curriculum renewal on school management practices. This research will investigate not only the direct impact of curriculum changes on school management, but also how school leadership, policies and organizational culture adapt to these changes. Result and Discussion

Identify Various Forms Of Impact Of Curriculum Renewal On School Management Practices.

Curriculum renewal is a very important process in improving the quality of education. In this process, the curriculum used by schools is changed and adapted to the needs and developments of society.¹⁷ Curriculum renewal can have various impacts on school management practices, both directly and indirectly. The following are several forms of impact that can occur:

Management Paradigm Change

Curriculum renewal can change the school management paradigm. In a curriculum that is more flexible and responsive to change, school management must be more innovative and adaptive in facing change. 18 School management must be able to adapt to curriculum changes and improve their ability to manage change.

Changes in Organizational Structure b.

Curriculum renewal can change the school's organizational structure. In a more project-based curriculum, school organizational structures must be more open and inclusive, school management must be able to manage changes in organizational structure and improve abilities in managing teams.¹⁹

Change in School Culture c.

Curriculum renewal can change school culture, in a more project-based curriculum, school culture must be more open and inclusive. 20 School management must be able to manage changes in school culture and increase capabilities in managing cultural change.

Changes in Teacher Skills d.

Curriculum updates can change teacher skills. In a more project-based curriculum, teachers must have a wider range of skills and be more flexible. School management must be able to manage

e. Changes in the Quality of Education

In a more project-based curriculum, students can have broader and more effective learning experiences.²² School management must be able to manage changes in the quality of education and increase their ability to manage changes in the quality of education.

f. Changes in Community Engagement

g. Change Management Skills

h. Changes in Resource Quality

Curriculum renewal can improve the quality of resources. In a more project-based curriculum, school resources must be of higher quality. School management must be able to manage changes in the quality of resources and increase their ability to manage changes in the quality of resources.²⁵

i. Changes in Student Engagement

Curriculum updates can increase student engagement. In a more project-based curriculum, students can have a more active role in education. School management must be able to manage changes

in student engagement and increase capabilities in managing changes in student engagement.²⁶

j. Changes in Service Quality

Curriculum renewal can improve service quality. In a more project-based curriculum, school services must be of higher quality. School management must be able to manage changes in service quality and increase their ability to manage changes in service quality.²⁷ In synthesis, curriculum renewal can have various impacts on school management practices, school management must be able to manage change and increase capabilities in managing change.²⁸ In this way, school management can improve the quality of education and increase capabilities in managing change.

In the overall impact of curriculum renewal on school management practices, changes in curriculum planning with adjustments to curriculum renewal priorities often lead to changes in priorities in the curriculum, school management must adapt their planning to these new priorities. For example, if curriculum renewal emphasizes the development of 21st century skills, school management needs to plan teacher training and other resources to support this implementation.²⁹ Then according to Halimah³⁰, the new curriculum may have different or expanded learning objectives. School management needs to establish strategies to achieve these goals, including adjustments to assessment and evaluation. Then curriculum renewal cannot be separated from the training and development of teachers so that they can teach effectively according to the new curriculum, school management is responsible for organizing this training, allocating resources, and evaluating its impact.³¹

Besides that, the new curriculum requires a different instructional approach, school management must ensure that teachers have the skills and resources necessary to adopt the new approach.³²

In research conducted by Kuntadi & Rosdiana³³, curriculum reform requires resource management through budget allocation for implementing a new curriculum, which may require budget re-allocation to support new needs, such as purchasing new textbooks, software or other teaching materials. Besides that, providing additional resources is an important part of new curricula that may require additional resources, such as learning software or laboratory equipment. In this case, school management must identify and acquire these resources.³⁴ Besides that, according to Wahidah et al³⁵, the involvement of parents and the community influencing school management is needed in communicating effectively regarding curriculum changes with the aim of understanding their concerns and including them in the implementation process. Besides that, ongoing evaluation is needed to ensure learning objectives are achieved and to identify areas that need improvement in the implementation of the new curriculum. After the evaluation is carried out, school management needs to be ready to make adjustments to their curriculum and learning practices based on the results of the evaluation.³⁶ Thus, continuous evaluation cycles and the ability to adapt are key in ensuring the effectiveness and suitability of the curriculum to the changing needs of students and the learning environment.

Present findings that can form the basis for developing more effective education policies and school management practices.

In essence, building a strong foundation for positive change in the education system requires the use of findings from evaluation and

assessment as the main guide.³⁷ In this context, we will explore how the results of this evaluation can provide a solid basis for formulating more effective education policies and improving school management practices.

In research conducted by Wati³⁸ regular and comprehensive evaluation is a crucial first step in producing findings that become the basis for developing more effective education policies. Such evaluations not only include the achievement of learning objectives, but also other aspects such as student satisfaction and the effectiveness of teaching methods. By basing educational policies on accurate and comprehensive evaluation findings, educational institutions can lead to changes that better achieve learning objectives and improve quality. overall education.³⁹ Furthermore, in research conducted by⁴⁰ identified the main findings in order to obtain results from significant achievements in achieving learning objectives and plan appropriate corrective actions to increase learning effectiveness and achieve better results for students. Next, making adjustments to education policies means that if the evaluation shows that the majority of students have difficulty understanding certain material, then it is necessary to consider adopting more interactive learning strategies or adjusting the curriculum to better meet students' needs. 41 Besides that, the findings from the evaluation can also help in the development of more effective school management practices. School management must use evaluation findings to assess the effectiveness of management strategies that have been implemented, such as learning time management, resource allocation, and student support.42 Then it is necessary to implement changes, based on
